## TUITION FEES

All students enrolling in the LL.M. in European Law must pay a tuition fee of 10,000 Euros, payable **in total** by **June 30<sup>th</sup>** of the Academic year preceding the year of enrolment. In addition, upon enrolment, students will pay administrative fees in the order of 260 Euros and Social Security fees in the order of 215 Euros.

Students enrolling in the LL.M. via an exchange program must check with their home university regarding the financial arrangement. In addition, they will have to pay upon arrival in Paris administrative fees in the order of 260 Euros and Social Security fees in the order of 215 Euros.

## DOCUMENTS TO JOIN TO THE PRESENT APPLICATION FORM

Please note that once you are physically in Paris, and before the academic year starts, you will be requested to show the originals of all documents in the list below:

- Certified copy of the **last degree** obtained (highest level) and its official translation (if not in English).

- Justifications of your **professional experience** (if applicable).
- Certified copy of the **TOEFL/IELTS/CPE** examination results (if English is not your native language).

## UPON ARRIVAL

- For non European students and students over 28 year: **health insurance statement** covering the stay in France.
